#### Welcome to our Spring Edition.

We would like to focus this season on Assistive Technology and how it is used by and benefiting some of our clients providing some of our clients.

For example Lisa has a number of clients who make use of this amazing technology, here are just a few:

Male client in his mid-40s who is blind, uses a powered wheelchair and lives alone. One night, whilst in bed he thought he heard someone trying to enter his property, by using Alexa to "turn on the lights" disturbed the intruders who in turn left. This device is not only controlling lights around his home but is also being used to remind him of appointments too, giving him ability to live independently.

Child using an app allowing him to keep a daily calendar of his school timetable along with activities he is involved with outside of school. It lets his mum add checklists to help him remember things too - the app is called Handicalendar.

Meanwhile a client who is a wheelchair user and struggles to transfer from his armchair to his wheelchair in time to answer the door if someone rings, is benefiting from using a 'smart doorbell' system. This system allows him to see from a camera who is at the door and then use the voice system to ask them to wait whilst he gets into his wheelchair.

I think you will agree it is amazing just how far assistive technology has come since 1974 and the talking calculator! We now have fabulous aids such as screen readers, wheelchairs controlled by the mouth to home automation. It will be interesting to see what the next 40 years will bring.
